Board Rule Changes –

Changes will be made to section 8 (b) (1) to state as follows -

If a quorum of the Members of the public body is physically present as required by the Illinois Open Meetings Act, a majority of the public body may allow a Member of that body to attend the meeting by other means if the Member is prevented from physically attending because of: (i) personal illness or disability; (ii) employment purposes or the business of the public body; or (iii) a family or other emergency. "Other means" is by video or audio conference. Any member attending a meeting by other means will be considered a voting member.
