### Daily Tri-county Update COVID-19 Peoria, Tazewell, Woodford Counties

Please note that there is one new death to report for Peoria County - a female in her 80's, hospitalized for over 2 weeks, and who resided at Bickford House.

The area hospital systems also reported 2 additional deaths of individuals who resided outside the tri-county region.

### COVID-19 Testing Collection Site Changes

Heartland Health Services has added a Pekin site to their Peoria Region locations for COVID-19 test collections. Beginning Wednesday, May 13, testing collection by drive-through or walk-up will take place from 9am – 4pm at Tazwood Center for Wellness, 3248 Van De Ver Ave., Pekin, IL. Anyone age 18 and older with or without COV-19 related symptoms can be tested. Testing is no cost to the public; bring an ID card; bring insurance documents if available but not required.

In addition, the Heartland Health Services testing collection site at John H. Gwynn Park at Faucet Field, Peoria, IL has changed to Tuesdays only from 9am – 4pm.

Other testing collection sites continue at Peoria City/County Health Department, 2116 N. Sheridan Rd, Peoria, on Saturday and Sunday from 10am-2pm and at Heartland Health Services, 2321 N. Wisconsin, Peoria, on Monday-Friday 9am-4pm.
